#### 1. BASIS OF PRESENTATION:

The accompanying schedule of expenditures of federal

grant activity of Smithtown Central School District (the District ) under programs of the federal government for the fiscal year ended June 30, 2023. The District has elected not to use the 10-percent de minimis indirect cost rate allowed under the Uniform Guidance.
